

Dear colleagues,

I am writing in support of PortSide NewYork's application for a National Maritime Heritage subgrant for the preservation of the Mary A. Whalen coastal oil tanker.

The historical significance of the Mary A. Whalen is well substantiated in its National Register listing. As one of the last surviving "bell boats," and a key element in a case that changed maritime law, her repair is easily supported by preservation criteria. The Mary A. Whalen is a *priority* preservation project because of the urgency of the proposed repairs to ensure her continued use as center for learning and community-based activism.

The survival and sustainability of the tanker and her educational mission are threatened by her nonoperational engine. Red Hook, where the Mary A. Whalen is moored, is a frontline community in the climate crisis. Its vulnerability is due, in large part, to flood and storm surge risks: Red Hook was one of the hardest hit NYC neighborhoods by Hurricane Sandy. Without a running engine, the tanker cannot seek safe harbor when the next storm comes and is thus in physical danger. This fact, combined with the risk posed by her location, prevents PortSide New York from securing adequate insurance for the historic vessel.

The climate vulnerability of Red Hook is exacerbated by long histories of disinvestment and overhardening of the shoreline, changes in shipping and waterfront industries, and the marginalization of the diverse publics who live and work there. The Mary A. Whalen serves as a critical conduit of education and community mobilization in ways that bridge historic preservation and climate action, and confront these neighborhood legacies in ways that center its shared maritime heritage. The work of PortSide New York was instrumental in the community's recovery from Hurricane Sandy, all of which depended upon the Mary A. Whalen as a place of gathering and learning. The tanker has been host to educational visits and community events that have leveraged resiliency planning and climate policy in Brooklyn and the city writ large. And equally important, the tanker serves as one of the few surviving places for students and the general public to experience the historic working waterfront of Red Hook. With the decrease in shipping industry activities and the conversion and loss of many waterfront properties to road-dependent warehouse facilities, the vital relationship of the neighborhood to the harbor is increasingly fractured and redeveloped. PortSide New York is a singular institution, preserving Red Hook's stories and its socialspatial connections to the water through the Mary A. Whalen. The functionality of the engine is thus imperative to the survival of the tanker itself and to the broader preservation and educational mission of PortSide New York.

As a faculty member in Columbia University's Graduate Program in Historic Preservation, I would assert that our ability to educate the next generation of preservation professionals hinges upon robust engagement with historic resources and their communities. How we preserve heritage is increasingly a collaborative endeavor that must respond to contemporary social and environmental conditions, and how histories of exclusion have helped to create inequities in those conditions. In early 2020, I had the privilege of working with PortSide New York on a preservation studio I taught, Red Hook, Brooklyn: Preservation as a Tool for Equitable Resilience. One of the core objectives of the studio was for students to learn and practice listening by identifying key organizations in the neighborhood, attending community meetings, and undertaking interviews. PortSide New York was readily recognized as one of those key organizations because it serves as a critical resource for understanding waterfront histories and how they underpin contemporary conditions and challenges. Through the physical and spatial experience of the Mary A. Whalen, PortSide New York helps visitors and collaborators connect past and present viscerally, with the wind blowing across the harbor, water lapping at the pier, and the sound of ship horns echoing. Repairing her engine will not only secure her survival, but enable a more sustainable future, one in which that experiential learning is expanded through events that allow students and visitors to travel into the harbor and along the shoreline.

PortSide and the Mary A. Whalen provide a model for the kind of deep investment needed to understand maritime history and the culture of waterfront communities, and to mobilize these historic assets toward equitable resilience and climate action. I write to support PortSide NewYork's application for historic preservation funding to do restoration work on the historic ship Mary A. Whalen as part of their campaign #makeMARYrunagain.

PortSide acquired the Mary Whalen from us in 2006.

The Mary Whalen is important to many of us on the working waterfront as the kind of historic ship that speaks to our work and the work of the modern port more than tall ships but normally receives no glory. The Mary is a 20th century workboat, a part of the towing industry, a hard-working ship that trained many a mariner and has some sea stories. The ship is very important in admiralty law due to the Supreme Court decision in U.S. vs Reliable Transfer.

The ship is also a "Bushey boat," maybe one of the last survivors of the fleet of tugs and tankers Bushey built in Red Hook Brooklyn and operated in the Northeast. Old-timers still wax nostalgic about Bushey boats.

The ship is a bell boat, an antique system for communicating between wheelhouse and engine room.

PortSide does a great job of making the ship available to the public, explaining the ship and the kind of work she did. PortSide is interested in training future mariners, a goal we appreciate, and they are trying to restore the ship to running condition to use her as a training vessel.

Our company regularly donates to PortSide, and we hope you will fund their grant application.

I am writing this letter of support to express my enthusiastic support for PortSide NewYork and their application for historic preservation funding to do restoration work on the historic ship MARY A. WHALEN.

I am the founder and Executive Director of The Waterfront Museum which is housed aboard the Lehigh Valley Railroad Barge #79, the only wooden barge of The Lighterage Era (1860-1985) still afloat. For its historical value, it is listed on the National Register of Historic Places. I rescued it from the mud in 1985 after it was made obsolete by major shifts in the shipping industry starting in 1956. Barges like the one now housing the Waterfront Museum transported tons of cargo like grains and other merchandise between the ships in the NY Harbor to railroad terminals in NJ in what was then the world's largest port. It is our mission to provide public waterfront access and programs in education and the arts aboard an historic vessel.

Having restored, maintained and developed programs for our 110 year old historic vessel, I understand the power and responsibility of preserving such a ship. PortSide and their ship are neighbors in Red Hook being just nine blocks away. Our ships are very different, but both are last of their kind. This kind of work is very difficult and I implore you to please consider a grant award for their efforts.

I am in full support of Carolina's efforts to develop her vessel as an educational and cultural attraction vessel. With her background as a photojournalist, she has proven herself quite capable of producing quality exhibitions and outstanding presentations. Red Hook Stories - the oral histories she has compiled are exquisite! She has quickly acquired the acumen and persistence. needed to negotiate the intricacies of owning and operating a vessel like the tanker Mary Whalen. It excites me to think that with your funding assistance might give new life to this old vessel.

I believe the Mary Whalen tanker to be a vital component to New York City's library of historic and educational vessels that have the capacity to entertain and educate the general public at our waterfront docks. Outfitted with its own mooring piles, a gangway from shore to the Mary Whalen could even make waterfront locations that lack a proper docking facility a possible destination for their programs throughout the waterways of New York and beyond.

I believe so much in Carolina and her project that I have informed her about funding sources while I myself am competing for these very same funds. I am confident that as we inspire and create waterfront town docks, these good deeds will snowball to enable us all to enjoy the great potential we have at our front doorstep.

The value PortSide NewYork brings to the citizens of the State of New York cannot be over-estimated. I unreservedly recommend you provide them funding. Thank you.

I am writing this letter in support of a proposal for funding for the PortSide NY, a not-for-profit organization serving the Red Hook community, and South Brooklyn. For the thriving community in a less-than advantaged area in Brooklyn, Summit Academy Charter School bridges the gap between aspirations and realities by preparing 6 th -12th grade scholars to gain acceptance to, excel in and graduate from college. The school is a vital conservancy of sustentiation for its youth and their families. It provides the fundamental and supplemental resources which enables a shift from the predetermined confines of their statistically disadvantaged communities. Conversely, SACS provides the environment and tools that sets a trajectory of success for students, equipping them to contribute and operate fully in the greater economy with expanded life choices. This inevitably serves and saves their community.

Summit's work with young people in the Red Hook community has afforded us the opportunity to work with PortSide and experience the potential for enhanced learning hidden within the Mary Whalen ship. PortSide was founded in 2005 to rethink NYC's relationship to the harbor by creating an innovative maritime center - a new model for NYC - showing how to combine the working waterfront and public access (busting local zoning conventions) while using maritime activity to drive community and economic development.

PortSide uses their historic ship, the coastal oil tanker Mary A. Whalen, and waterfront locations to teach via "place based education. Summit scholars have benefited from the ship's close proximity to the school. The Mary Whalen has enhanced learning opportunities for our scholars and could be even more beneficial if she were mobile, as scholars would be able to access the waterfront on the ship. The MARY is the last of her kind in the USA and on the National Register of Historic Places. She is a museum of herself and a vital community center for Red Hook, Brooklyn. She is NYC's favorite oil tanker and a great platform to teach about USA fuel consumption and how that relates to climate change.

As a neighborhood cut off from the rest of Brooklyn, Red Hook is one of New York City's most underserved communities. Given the lack of resources in this community, it is crucial that collectively we protect those that exist. Restoration of the Mary A. Whalen is critical if we are to continue to expose scholars to maritime work as well as broaden the horizons of inner city Youth.

As the founder of Summit Academy Charter School, and a member of the Board at PortSide, I can say with confidence that PortSide and the Mary A. Whalen are integral components of this community and your support in the restoration of this ship will bolster PortSide's ability to be a beacon of light in this community.

One such treasure is PortSide NewYork and their ship Mary A. Whalen. This amazing non-profit organization located at Pier 11 provides all who visit with the opportunity to learn some history and science while having one of the best views of the New York skyline. The historic Mary A. Whalen oil tanker provides many with educational opportunities about the waterfront of Red Hook, its ecology, and resilience, and local maritime history of which this ship is a strong part.

PortSide NewYork has already done so much for the community, such as organizing educational and cultural events on the ship, supporting local politicians advocating for the best interests of the people of Red Hook, and partnering with local schools and businesses to give residents opportunities to access resources that address all sorts of needs. The ship Mary A. Whalen is now a floating community and education center for youth and adults and made relevant in so many ways.

Since Superstorm Sandy, PortSide has been informing the public how to be resilient and prepared in the face of severe weather. Sandy hit Red Hook hard, and PortSide was there to help Red Hook recover and become more resilient. Now, one of the organization's missions is to provide community members with the education required to better handle extreme weather. I was a teacher hired by PortSide to create curriculum, supported by a federal DOE grant, to develop a high school curriculum about this. Their crew actually rode out Sandy on the ship, making the ship a powerful platform to talk about the issues of hurricanes, flooding, and sea level rise; and as an oil tanker, the ship is a great means to talk about the history of fuel consumption in the city, region and USA.

Overall, this hidden treasure provides those who visit, and/or use their online resources, with opportunities to learn, experience, and be informed about what makes Red Hook great, including ships and our waterfront, how Red Hook has changed, both historically and naturally, and for residents to be ready and supported for what unknown variables that we may encounter.

I experienced the glory of New York Harbor on board a beautiful old tanker with a vintage kitchen and cabins.

The maritime history of the city fascinates me, and should be valued in all forms. Preserving the Mary Whelan is one. The ship is the only oil tanker open to the public. This makes the ship a special resource plus all the special ways PortSide has created to use this ship and make it welcoming to the community. We need this ship saved and restored. The Mary A. I discovered the Mary A Whalen at PortSide in the spring of 2016 and immediately volunteered to work aboard her to help with restoration, renewal and support of PortSide's staff. I continued working there for three years, frequently working 20 to 30 or more hours per week.

My interest comes from my maritime background. I have been sailing and maintaining recreational boats since my adolescence. I owned several sailboats from the 1970's through the 1990's and cruised with my family along Long Island Sound from Manhattan to Newport and Martha's Vineyard. I have been a member and officer with the United States Sail and Power Squadrons since 1980 where I have qualified in and taught courses in navigation, seamanship, sailing, engine maintenance, marine electronics and weather. Since Red Hook took one to the chin during Superstorm Sandy, it is vital that helpful information is available for all who live there. The PortSide team is the one community source that facilitates this information, making sure it reads well for all residents—not just those folks who live in private homes but also the thousands of underserved folks who reside in NYCHA housing nearby.

Before New York became a city, it was a port. The *Mary A. Whalen*, the last of the oil tankers, is the only one of its kind open to the public. This makes the ship a special resource plus all the special ways PortSide has created to use this ship and make it welcoming to the community. The ship helps visiting students connect back to New York's role as the most important port city in the United States. And informs them of how vulnerable New York Harbor is to climate change, and how those changes affect all the coastal neighborhoods, including Red Hook.

Please fund PortSide so that future generations benefit from knowing about New York's maritime history and how to take measures to protect themselves from nature's fury!

I am currently traveling to Berlin, Munich and Amsterdam for meetings with former planning development colleagues; but I feel strongly about PortSide so I am emailing while en route.

I am a city planner with 60 years of experience providing architectural, planning, community economic development and sustainable development assistance to community-based groups in low- and moderate-income neighborhoods. I have worked in Red Hook for decades and supported and watched the neighborhood's transformation as it fought its way up from blight, the crack epidemic of the 1980s, and the early 1990s murder of elementary school principal Patrick Daly. I participated in creating Red Hook's 197a plan, one of the first in NYC, in 1994. I also worked with residents of Red Hook in the aftermath of Superstorm Sandy and with colleagues from Pratt Institute launched the RETI initiative that was designed to link the diverse population of Red Hook to address issues of climate change.

Red Hook had many special historic structures, most of them industrial, and many have been destroyed in just the past 20 years by the forces of unthoughtful and ill planned development. PortSide NewYork and their historic ship Mary A. Whalen buck this trend.

PortSide NewYork is a significant grassroots player in contributing to Red Hook's community's social and economic development, to its recovery from Sandy and its future resiliency, and they have created inventive and compelling ways to make their historic ship a cultural, educational and community center.



It takes a long memory to recall when New York Harbor had its own floating maritime trades school. *SS John W. Brown* not only taught essential entry-level skills for well-paying jobs aboard ship in the US merchant marine, by its existence the school preserved one of the last fully-functioning Liberty ships which were essential to the Allied victory in World War II.



It is thanks to the passionate, dedicated, heroic efforts of Ms. Carolina Salguero that *MT Mary Whalen* did not meet the same fate as virtually all of the Liberty ships; in fact *MT Mary Whalen* is even more rare than a Liberty ship, being the very last of her class. The ship is worthy of support on historic merit in that in scale, mode of operation and type of propulsion system she was the enabling technology that transformed the marine shipping industry from filthy dirty coal-powered engines to less-dirty, more efficient oil-powered engines. Built for her rugged work of refueling deep-sea ships in NY harbor, *MT Mary Whalen* never physically wore out; she became victim of her own success as ever-larger oil-powered ships required ever larger and more economical bunkering ships.

But *MV Mary Whelan* is far more than an interesting and valuable historic relic. By restoring *MV Whalen* to a fully-functioning inland and coastal vessel, Port-Side NY will build upon already invaluable community educational outreach programs in a way that is particularly valuable to today's and tomorrow's US maritime industry, starting in New York Harbor but reaching across our nation, indeed spanning oceans. The issues are numerous but in brief, the US maritime industry is soon going to require many more qualified mariners who are going to look a lot like former graduates of programs such as were offered aboard *SS John W. Brown.* The payback to New York State and beyond from hands-on skills learnt by putting *MT Mary Whalen* back in working order are incalculable, and coincidentally perfectly timed if supported now. TransTech / ShipShares LLC believe NMH will not find a sub-grant project more worthy of support than restoring *MT Mary Whalen's* self-propulsion capability, and expanding educational
